Gay Softball World Series Commitment**

OBJECTIVES:

The purpose of CCSL is to foster local, regional, national and international sports competition predominately for gay, lesbian athletes. In so doing, we encourage all of the teams within our league to travel nationally/internationally to compete in ASANA/NAGAAA sanctioned events, especially the Gay Softball World Series (GSWS). Considering the GSWS is the pinnacle achievement of our league, you must earn the right to compete in this annual event by earning a berth within the local league. Berths are given based on the total number of teams in the league and decided by the team with the top record within divisional play during a competitive season.

Due to this extreme generosity on the part of CCSL, we want all the teams attending the GSWS to be held accountable for their actions on and off the field as they are representing themselves, Phoenix, and CCSL. We want you to take this competition very seriously and show good sportsmanship at all times. By declaring World Series intent, your team is committed to attend the GSWS in its entirety if you win the divisional berth, to complete to the best of your ability, and above all represent yourselves in an honorable fashion. If you win the berth, your team is required to put down a \$300 deposit payable to CCSL, Inc. and is due no later than two (2) weeks after the completion of competitive play.

Should your team declare WS intent and not attend the GSWS, your team will be required to offer written explanations to CCSL's commission as to why your team did not attend the tournament, to explain what efforts if any were taken to remedy any hardship or extenuating circumstances, and how you gave enough time for another potential team to attend the GSWS in your place. Likewise, the team will be ineligible to play in any CCSL sanctioned event until the entry fee, hotel deposit, and any additional per-diem is repaid in full to CCSL along with forfeiting the \$300 deposit paid to the Cactus Cities Softball League at the completion of the competitive season.
